GENERAL FUND

General Fund Collections of \$3.8 billion for the month of December were \$464.3 million, or 13.7 percent, above the official estimate. Fiscal year 2021-22 collections of \$22.6 billion were \$1.5 billion, or 7.0 percent, above estimate.

• Total Corporation Tax collections of \$913.4 million for the month of December were \$259.4 million above the official estimate. Year-to-date collections are \$577.2 million, or 30.7 percent, above estimate.

• Sales and Use Tax (SUT) collections of \$1.2 billion were \$101.9 million above estimate. Year-to-date collections are \$409.1 million, or 6.2 percent, above estimate.

• Total Personal Income Tax (PIT) collections of \$1.3 billion for the month of December were \$59.5 million above estimate. Year-to-date collections are \$308.0 million, or 4.7 percent, above the official estimate.

• Realty Transfer Tax (RTT) revenues of \$91.6 million were \$24.5 million above estimate. Year-to-date collections are \$44.0 million, or 12.2 percent, above estimate.

• Inheritance Tax revenues of \$143.2 million were \$24.9 million above estimate. Year-to-date collections are \$50.2 million, or 7.1 percent, above estimate.

• Other tax revenue including Cigarette, Malt Beverage, Liquor, Gaming, and other miscellaneous tax collections totaled \$164.6 million for the month of December.

• Nontax revenue collections for the month of December were \$10.5 million above estimate. Year-to-date collections are \$61.5 million, or 1.5 percent, above the official estimate.

MOTOR LICENSE AND GAMING FUNDS

Motor License Fund collections of \$208.5 million in December were \$14.2 million above the official estimate. Fiscal year 2021-22 collections of \$1.4 billion were \$61.3 million, or 4.5 percent, above the official estimate.

The State Gaming Fund collected \$78.3 million in December. Fiscal year-to-date collections for the fund total \$540.0 million.






