#### **GENERAL FUND**

General Fund Collections of \$4.0 billion for the month of December were \$319.9 million, or 8.6 percent, above the official estimate. Fiscal year 2022-23 collections of \$19.7 billion were \$503.1 million, or 2.6 percent, above estimate.

The majority of the surplus in December is attributable to personal income tax revenue that was deposited on the first day of the month, rather than on the last day of November, as initially expected. Ultimately, this one-day shift of revenue had a minimal impact on overall General Fund collections.

- Total Corporation Tax collections of \$1.0 billion for the month of December were \$116.3 million above the official estimate. Year-to-date collections are \$328.7 million, or 13.6 percent, above estimate.
- Sales and Use Tax (SUT) collections of \$1.2 billion were \$2.3 million below estimate. Year-to-date collections are \$134.8 million, or 1.9 percent, above estimate.
- Total Personal Income Tax (PIT) collections of \$1.4 billion for the month of December were \$204.9 million above estimate. Year-to-date collections are \$27.1 million, or 0.4 percent, above the official estimate.
- Realty Transfer Tax (RTT) revenues of \$55.8 million were \$23.3 million below estimate. Year-to-date collections are \$26.7 million, or 7.1 percent, below estimate.
- Inheritance Tax revenues of \$138.0 million were \$6.1 million above estimate. Year-to-date collections are \$16.3 million, or 2.2 percent, below estimate.
- Other tax revenue including Cigarette, Malt Beverage, Liquor, Gaming, and other miscellaneous tax collections totaled \$174.2 million for the month of December.
- Nontax revenue collections for the month of December were \$23.3 million above estimate. Year-to-date collections are \$88.0 million, or 34.0 percent, above the official estimate.

### **MOTOR LICENSE AND GAMING FUNDS**

Motor License Fund collections of \$203.0 million in December were \$8.2 million above the official estimate. Fiscal year 2022-23 collections of \$1.4 billion were \$25.0 million, or 1.8 percent, above the official estimate.

The State Gaming Fund collected \$87.5 million in December. Fiscal year-to-date collections for the fund total \$565.6 million.





#### 2022-23 GENERAL FUND REVENUES







