## TRACK STATUS



Check the status of your return or application 24-7:

- **Track My Inheritance Tax Return:** REV-1500 Inheritance Tax Return (original filings only)
- **Where's My Refund?:** PA-40 Personal Income Tax Return
- **Where's My Rebate?:** PA-1000 Property Tax/Rent Rebate Application
- **Find a Submission:** View details from a payment or return submitted through *myPATH*

## RESPOND



Respond to letters received from the department:

- **Respond to a Letter:** Upload and submit requested documents directly to the department
- **Enter Verification Code:** Verify your refund using the Verification Code from your letter
- **Take ID Verification Quiz:** Complete the quiz to verify your refund and your identity
